Current Projects & Future Research

- *Personalities of Political World Leaders*
This project includes several tracks, including a project (*Breaking Bad*) on how leader personalities change over time, funded by a Leverhulme Trust Major Research Fellowship, 2023-2025. I continue to work with Consuelo Thiers and Ryan Beasley on leader profiling, and recently completed a counterfactual analysis (with Kai Oppermann and Ryan Beasley) on leaders in the reaction to the 2022 Russian invasion of Ukraine. I am also working on a paper with Julia Calvert on personalities in Latin American reactions to windfall profits.
- *National Roles: Internally Contested Role Conceptions and External Socialisation*
This research extends my prior theoretical and empirical analyses of internal disagreements over national role conceptions and their influence on foreign policy. I am currently working with Oppermann and Beasley on an article on roles in world order transitions, to be published in a special issue in *Global Studies Quarterly*.
- *Coalition Cabinets, Political Parties, & Parliaments in Foreign Policy and International Politics*
My research continues to examine the effects of coalition cabinets and political party disagreements on foreign policy. I am part of a research team doing comparative analyses on parties' positions on military deployments and trade agreements and the politicization of foreign and security policy in parliamentary votes. We have created a database of deployment and treaty votes (<http://deploymentvotewatch.eu/>).
- *The Future of Foreign Policy Analysis (FPA)*
I am co-editing (with Cameron Thies) *The Oxford Handbook of Foreign Policy Analysis*. This Handbook aims to re-position FPA to a central analytic location within the study of International Relations. I have also co-authored an article with Cristian Cantir on Comparative Foreign Policy for Thies (ed) Handbook on International Relations (Edward Elgar Publishers)

Teaching Experience

Breadth: I have taught more than 70 semester-length courses on more than 15 different topics.

Innovative Teaching: My classes stress theoretical, critical, and interdisciplinary analyses. I incorporate structured debates, policy briefs, and role-playing simulations in my classes to generate interest and internalization of the material. I have introduced the 'fishbowl' method in larger classrooms to facilitate discussion (small numbers of different students are rotated into the 'fishbowl' each week and are responsible for answering questions and making comments on course material; other students are on the perimeter and learn from the small groups' interactions).

Pedagogical Outcomes: Successful undergraduates leave my classes as better-informed global citizens with enhanced writing, research, and presentation skills to prepare them for a range of careers in law, politics, public policy, or international relations. At the graduate level, I focus on providing research skills that will serve students in academic and non-academic environments. I consistently receive excellent evaluations at all levels of teaching.
