# What is Politics and who is it for?

Politics studies the theory and practice of how societies are governed. How do our political institutions create collective rules, who has the power to make them and what are the consequences of political decisions? What is the nature of a just society and how do we achieve it? Politics students explore the origins and present-day contexts of societal conflicts about power, participation and resources. They study not only the processes of governance at the local, national, and international levels, but also the morality of political action and the limits of freedom and justice.

Politics can be studied as a single honours degree or combined with the following subjects as part of a joint honours degree:

Arabic, Economics, French, German, History, Italian, Law, Philosophy, Quantitative Methods, Russian Studies, Scandinavian Studies, Social Anthropology, Social Policy, Sociology or Spanish.

# What is International Relations and who is it for?

International Relations (IR) studies actions and challenges that transcend national boundaries, and the resulting conflicts or attempts at cooperation. How do states cope with our highly complex and interconnected world, and how can we tackle problems like climate change, global economic inequality or interstate war? Do our very ideas about state power, sovereignty, democracy, justice, legitimacy and order have to change when we think about the international level?

IR students explore the origins and evolution of the state system, the emergence of global non-state actors, the power of international institutions and the driving forces behind international cooperation and conflict.

# What you'll typically study

Your undergraduate degree in Politics or International Relations will cover a comprehensive core of subjects, giving you a sound introduction to the subject and the flexibility to study topics within and outside it.

# Summary of Politics and International Relations courses

### Politics and International Relations 1A:

Concepts and Debates. PIR1A introduces key concepts such as power, participation and representation. Each week revolves around an important political question, the associated concepts, and the societal and academic debates around it.

### Politics and International Relations 1B:

The Global Dimension. PIR1B introduces key concepts such as collective security, multilateralism and human rights. Each week focuses on a key question of international politics today, the associated concepts, and the international and academic debates around it

Political Thinkers aims to introduce students to historical writers whose thoughts on politics - international or domestic - shape the way we understand the global challenges we face today. The content of the course is innovative in two respects: first, it conceives of political thought as a unified discipline encompassing thinking pertinent to both Politics and International Relations; second, it aims to decolonise the canon institutionalised in Western academia by pluralising the voices discussed over the course of the term

# **Introduction to Political Data Analysis**

explores how to access relevant data and assess the appropriateness of data. It provides key skills in quantitative data analysis, and shows how using different types of data and different techniques provide different ways to answer the types of questions typically posed by empirical politics and IR scholars.

## Theories of International Relations

introduces students to a diverse range of theoretical frameworks for making sense of international politics. It also engages key debates and cutting-edge research about how to understand international politics, and presents theory as a transferable skill, something we never stop using to identify, analyse and understand various international political phenomena.

# **Comparative Politics in a Globalised World**

will provide students with the conceptual knowledge and practical skills to understand comparative politics with a global perspective. It introduces the comparative method and applies that method to core questions and issues of comparative and international politics. These questions will cover political regimes, state formation and institutions, political and economic development, democracy, order and violence.

# Research Design in Politics and

International Relations will equip students with the skills necessary to understand, critically assess and undertake the research design process. Students will gain a good grasp of the behavioural assumptions in social science research and knowledge of a range of data collection methods (and how to assess the appropriateness of each), as well as the steps within a successful research project design.

# **Teaching**

Year one and two students typically have six to nine hours per week of lectures and three tutorial hours a week. The lectures are large but tutorial groups will normally have no more than 15 students.

Courses are typically assessed through a combination of essays and exams but can also include tutorial participation and various types of written assignments.

At Honours level (years three and four) teaching most often takes the form of seminars led by staff members. These can feature discussions, simulations, group presentations, or projects. Assessment varies between courses, but typically combines written assignments - such as essays, literature reviews, policy briefs, or blog posts - with marked participation, or presentations.

It is expected that students will engage in independent study and learning throughout their degree, based on the guidance provided by course reading lists.

# **Study Abroad**

We offer students an extensive range of opportunities to study abroad as part of their degree. Our exchange partners include a wide range of institutions across the world, including universities in the US, Canada and China.

In addition, Politics and International Relations has exchange schemes with the University of Leuven, University of Copenhagen, University of Grenoble, Sciences Po Paris, Free University Berlin, University of Cologne, LUISS Rome, Bocconi University Milan, University of Nijmegen, Jagiellonian University in Krakow, Pompeu Fabra University Barcelona, Comillas Pontifical University Madrid, Bilkent University, O.P.
